

## **TERMS & CONDITIONS – VALET PARKING SERVICE**

The following provisions shall apply to FAB credit cards, in addition to the terms set out in the First Abu Dhabi Bank PJSC Master Credit Card Conditions.

Any terms not defined within these terms and conditions shall have the meaning as defined in the First Abu Dhabi Bank PJSC Master Credit Card Conditions.

1.FAB Credit Cardholders are entitled to avail up to 4 complimentary valet parking services every calendar month by presenting their valid FAB Card at any of the below locations:

2. The eligible FAB Cards, monthly spend requirements and entitlements are as follows:

- 3. The valet parking service is valid for 1 st hour only and the customer will need to pay from the 2 nd hour onwards directly to the service provider
- 4. The total number of eligible services are set at the customer relationship level, including primary and supplementary Cards.

For example: A customer has three (3) credit cards: Elite Infinite, Infinite and Signature Cards.

- If total monthly spend on all three credit cards > AED 10,000, cardholder is eligible for 4 free valet parking transactions per calendar month;
- If total monthly spend on all three credit cards > AED 6,000 and < AED 10,000, card holder is eligible for 3 free valet parking transactions per calendar month;
- If total monthly spend on all three credit cards > AED 4,000 and < AED 6,000, cardholder is eligible for 2 free valet parking transactions per calendar month;
- If total monthly spend on all three credit cards < AED 4,000, cardholder will be charged for the valet parking service.
- 5. In case the minimum monthly spend requirement is not met or the usage criteria is exceeded, the prevailing valet parking rate at the location will be charged to the customer's Credit Account and will be posted in the next credit card statement following the month the services were availed. Excess valet parking charges are not reversible.
- 6. One valet parking service availed at the Dubai International Airport will be equivalent to two valet parking services.
- 7. This valet parking service is provided by Valtrans and is subject to availability of parking space.
- 8. The Bank reserves the right to add or delete any location and to modify the minimum monthly spend criteria at its own discretion.
